Position Summary: The Catering Sales Manager's purpose is to solicit, book, plan and coordinate catering sales by actively selling and up-selling each business opportunity. This position reports to the Senior Business Development Manager.

The Catering Sales SManager gathers event information and works with event coordination teams to be implemented and drives customer loyalty by delivering service excellence throughout each experience. The Catering Sales Manager maintains a thorough knowledge of Fort Worden and all its grounds, products, and services as well as awareness of other roles and responsibilities throughout the organization and is responsible for driving sales initiatives of other services. In addition to maintaining our vision by adhering to our values, this position must provide the highest level of service to our guests in all sales related functions while maximizing rate and occupancy.

Principal Duties and Responsibilities

- Up-sell products and services for group events, closing the best opportunities for Fort Worden based on market conditions and property needs
- Ensure that sales progress seamlessly and accurately by following established process and procedures
- Gather and input all important customer data in order to plan appropriately (e.g. customer's goals, specific needs, key account info, etc.)
- Provide accurate, complete and effective service in conjunction with the Event Coordination and the Food & Beverage team(s) for execution
- · Confirm final billing accuracy prior to and then send to Finance for final billing
- Coordinate event planning aspects prior to the business turning over for business booked in advance (greater than one year out)
- Gain and maintain an understanding of the overall market (e.g., competitors' strengths and weaknesses, economic trends, supply and demand etc.) and sell against them
- Identify operational challenges associated with a group and determine how to best work with the property staff and customer to solve these challenges and/or develop alternative solutions
- Adhere to all standards, policies, and procedures
- Support other members of the Sales Team, stepping in to assist in duties as appropriate
- Attend and participate in staff meetings as required
- Perform other duties, responsibilities, and special projects as assigned
